BICYCLE LOCKER RENTAL AGREEMENT**

1. RENTER INFORMATION (Please verify and make any necessary corrections and/or additions)

2. RENTAL AMOUNT is **\$7.50** per month. The renter shall be billed **\$45.00** semi-annually in advance.

3. KEY DEPOSIT of **\$50.00** is required in advance from the renter. If the renter does not return the locker key to NJ TRANSIT or its agent at the address below upon expiration or termination of this agreement as noted in Section 5, NJ TRANSIT or its agent shall be entitled to recover possession of the locker, retain the key deposit and dispose of any property remaining in the locker in accordance with Section 6 of this agreement.

4. LOCKER NUMBER AND RENTAL PERIOD. The renter is assigned locker number ____ at the _____ station. This agreement commences on _____ and expires _____ unless payment for a subsequent rental period is received from the renter by NJ TRANSIT or its agent not less than ten (10) days before the expiration date.

5. TERMINATION OR CANCELLATION. The renter must give written notification to NJ TRANSIT or its agent, at the address below, thirty (30) days prior to vacating the locker. Upon termination or cancellation, the renter must **tape the key to a piece of paper and mail it back to the address below**. After inspection of the locker and assuming no damages, the key deposit will be returned. The key deposit will be forfeited if damages to the locker or lock exist, or if the key is returned in any other way. NJ TRANSIT or its agent may also cancel this agreement at any time upon giving the renter thirty (30) days written notice and refunding any remaining full months of rental payment.

6. INSPECTION OF LOCKERS BY NJ TRANSIT OR ITS AGENT. This agreement entitles the renter to store one bicycle and related bicycle equipment (such as helmet, pump, or lock) in the above-designated locker for the above-designated time period. This agreement expressly prohibits use of the above-designated locker to store items such as tables, chairs, cartons, vending carts, inventory or merchandise. NJ TRANSIT and its agent expressly reserve the right to inspect lockers with or without notice to the renter. The renter agrees that NJ TRANSIT and its agent have the right to ensure that only a bicycle and related equipment are kept in the locker. If items other than a bicycle or bicycle-related equipment are stored in the locker, NJ TRANSIT and its agent reserve the right to terminate this agreement forthwith as well as all rights of the renter to receive a refund described in Section 5 of this agreement. NJ TRANSIT or its agent will promptly notify the renter of the termination in writing. Upon such termination, NJ TRANSIT and its agent have the right to empty the locker of any property stored therein. Such contents will be held by NJ TRANSIT or its agent for fourteen (14) days and then disposed as unclaimed property. Any renter whose agreement has been terminated by NJ TRANSIT or its agent is prohibited from renting an NJ TRANSIT bicycle locker for a period of one year.

7. LIMIT OF LIABILITY OF NJ TRANSIT AND ITS AGENT. NJ TRANSIT, its agent, and their employees are not responsible for fire, theft, loss or damage to the bicycle or any other item left in the locker. The renter is responsible for ensuring the locker is locked and for the security of the key. This agreement may not be amended unless such amendment is in writing and signed by the renter and NJ TRANSIT or its authorized agent. No employee or agent may alter the liability of NJ TRANSIT or its agent under the terms of this agreement.
