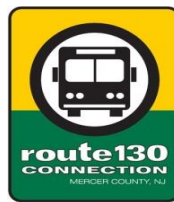

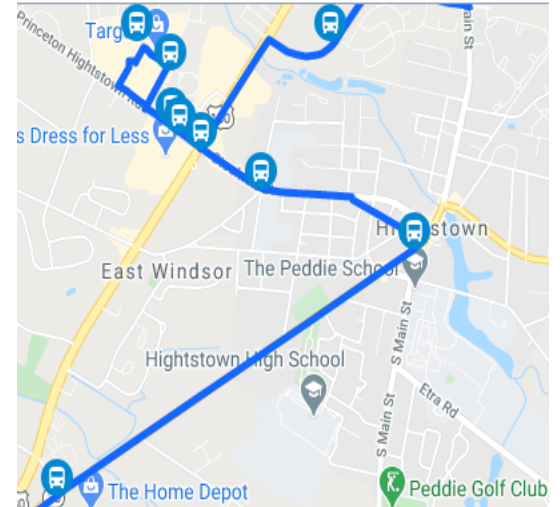

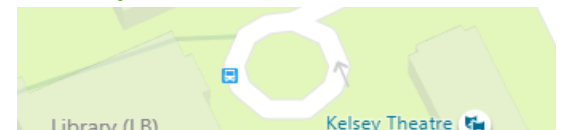
East Windsor-Hightstown Routing
